Re: Contract Negotiations

Dear Trustees, Mr. D'Angelo, and Negotiating Committee Members,

Over the past several months I had the opportunity to speak with many of you and members of the community-at-large about the ongoing Teachers' Contract negotiations between the Bayonne Board of Education (BBOED) and Bayonne Teachers Association (BTA). Many of these individuals include teachers and parents, and almost all of them are taxpayers. We all have a stake in the ultimate success of our education system, whether it is as critical as the valuable knowledge imparted on our children, or as economical as the value of local homes.

To that end, many of these individuals have expressed growing frustration and confusion about the current situation with negotiations. Quite frankly, I share in their frustration. In an effort to move the process forward I would like to invite you, both parties, to City Hall for a full day to discuss the current situation with the ultimate goal of coming to a resolution that is equitable for teachers, taxpayers, and, most importantly, the children who attend our schools.

My proposal is to host a full day session at City Hall on Thursday, November 10, 2016 beginning at 10:00 a.m. I also offer my conference room, private offices for conferring within your respective negotiation teams, and the support of members of my staff.

This offer is in a good faith effort to objectively further the discussions that have gone unresolved over the past year. I think we can all agree that the equitable resolution of these negotiations are in the best interests of all parties and stakeholders involved.
