**Narrative**

On 12/03/2017 while working as West Patrol Unit 602, I P.O Viola was dispatched to the West District for a walk in complaint.

Upon arrival the u/s met with Chris Gadsen, who states that he has a reoccurring issue with a few people. He informed the u/s that he is currently campaigning for the Ward B District 33 Councilman position. Ward B is the areas of Clairmont, Yale, Clark, And Ege Ave. Between West Side and Route 440.

Mr. Gadsen states yesterday 12/02/2017 around 1800 hours (6pm) himself, Frank Gilmore and a few others were displaying flyers in the District 33 area about his campaign. He then stated that during this he observed Former Councilmen Phil Kenny and David Donnelly removing the flyer to his campaign. After noticing such acts Mr. Gadsen approached them and spoke briefly with them requesting to not do such acts towards his campaign material. Mr. Gadsen was informed that they were just cleaning up.

Moments later while on Virginia Ave continuing their distribution of flyers, Mr. Gadsen received a phone call, stating a Mr. Jonathan DePhilapo was removing his material on the homes they placed flyers, Mr. Gadsen then quickly approached this individual and once again requested for them to not remove his material.

During this he also observed numerous others removing his material. He stated a Mr. Rolando Lavarro (Council President), Mira Prinz-Arey and Paul Bellen-Boyer were all in the area removing his campaign material.

Mr. Gadsen informed the u/s he was tired of his material being removed and throw out or places in bags. He had no further information at this time.

Mr. Gasen was advised that even though these acts were dishonorable they did not violate any statues or city ordinances at this time.
