WHEREAS, in response to the RFP, several proposals have been submitted to provide Special Counsel services for the City of Union City for the period commencing July 1, 2018 through June 30, 2019 at the rate of \$150.00 per hour and each contract shall not exceed \$20,000.00; and

WHEREAS, the proposals submitted meet the selection criteria articulated in the RFP; and

WHEREAS, the Board of Commissioners deems it in the best interests of the City to award Contracts to the following to provide Special Counsel services, as needed, to the City for the period July 1, 2018 through June 30, 2019 in accordance with the RFP:
