My name is Nuria Sierra. I reside in Jersey City, New Jersey, and have worked at the Jersey City Employment and Training Program (JCETP) for the past 22 years. My position is that of Accounts Payable Clerk. My work product has always been proficient.

I write this letter to inform you of the actions of Mr. Sudhan Thomas, Acting Executive Director of JCETP. Mr. Thomas' actions, which I set forth below, are clearly in violation of JCETP policy and General Accounting Principles, if not New Jersey law. Mr. Thomas, since his appointment as Executive Director, has continuously misappropriated funding and has jeopardized the financial integrity of the agency.

On two previous occasions, I have notified the New Jersey Department of Labor and Workforce Development of his actions, which emails are attached to this letter. In addition, I have notified two JCETP board members of Mr. Thomas' failure to provide for health insurance premium payments.

On July 5, 2019, I was notified that I was placed on Administrative Leave (letters attached) without demonstrated cause or explanation. It is my contention that Mr. Thomas placed me on Administrative Leave not as a result of my performance but rather due to his concerns with my objections to his financial mismanagement and my reporting relationships with the New Jersey Department of Labor and Workforce Development.

In conclusion, I stand ready to cooperate with legal authorities and law enforcement to ascertain the truth and take any responsible action in response to Mr. Thomas' conduct.

Anyways, please check the following:

Sudhan opened 5 accounts in another bank (BCB) Please check April and if possible May.

He has not given Angel or me access to the accounts.

We received a reimbursement check from one of our grants (CDBG) that ended in December 2018. He has been using that for non-dol expenses.

He does not believe me when I told him that the \$ was already spent and it was a reimbursement for WIOA \$.

He also wants to keep Reentry program going even though we have no funding for it. In April through the new bank account he made a check out for \$7500 for repairs bypassing the AP process. We don't have an invoice just copy of the check. He has been given employees loans through payroll which is not allowed according to our policies. This was done in APRIL and May.

He bought 3 laptops and printers without going through the proper process.

We don't have an IT person he's using a company who bill us monthly.

We are in default with our old copier lease because he decided to get other copy machines bypassing our lease. That machine is sitting in the front not being used. Ask for leases of copy machines.

He refuses to send Deo, Owen and Lisa's paychecks that have been sitting here since February. You will see them outstanding in the Provident Payroll Bank Recs.

He hires consultants Without agreement.


He doesn't want to pay our vendors! I do AP checks and they might sit here for weeks.


I'm hoping that you guys can step in and show him the proper way since he totally does not listen to my input. I'm actually banned from speaking to him lol!
