RESOLUTION URGING THE GOVERNOR, THE STATE LEGISLATORS AND THE NEW JERSEY TRANSIT TO TAKE ANY AND ALL ACTION NECSSARY TO ENSURE THE SERVICE PROVIDED BY BUS #30 SOCIETY HILL, #31 – MONTGOMERY AND WEST SIDE, #32 - 440 SHOPPER AND #33 BERGEN AVENUE BUS LINE, CONTINUE TO SERVICE THE HUDSON COUNTY COMMUNITY

WHEREAS, A&C Bus Line has announced its intentions to discontinue servicing of the Society Hill bus line, Montgomery/West Side bus line, 440 Shopper bus line, and Bergen Avenue. A service that has been provided to Hudson County residents for several years; and

WHEREAS, Society Hill bus line, Montgomery/West Side bus line, 440 Shopper bus line and Bergen Avenue bus line are a vital public service to the community it serves. They enable residents with transportation that enhances their lives and gives them the ability to safely and conveniently go shopping for groceries and everyday necessities; and

WHEREAS, the discontinuation of the said transportation would result in residents having to walk long distances in order to provide their families with items needed by every household in order to ensure a good quality of life. This is especially burdensome during the hot summer and cold winters months. It would require residents to have to carry heavy packages long distances putting their health and safety at risk.

NOW, THEREFORE, BE IT RESOLVED by the Hudson County Board of County Commissioners that:

- 1. The Governor, the State Legislators and the New Jersey Transit to take any and all action necessary to ensure the service provided by Society Hill bus line, Montgomery/West Side bus line, 440 Shopper bus line and Bergen Avenue bus line continue to service the Hudson County Community operates and reserves including appropriating necessary resources; and
- 2. That a copy of this Resolution be forwarded to the following: The Honorable Phil Murphy; Hudson County's delegation to the State Legislature the Commissioner of Transportation, New Jersey Transit; and the Municipal Clerk of the City of Jersey City.
