78. Narrative On Thursday, May 21, 2026, my partner, P.O. J. Ocasio #3266, and I, P.O. F. Rodriguez #2727, were assigned to marked patrol unit West 503. At approximately 2020 hours we were dispatched to Public School #11 located at 886 Bergen Ave for a complaint of an unruly parent who was being disruptive during a board meeting. Upon our arrival, we were met with the Director of Security, Mr. Rhudell A. Snelling. Mr. Snelling advised us that both he and the Board Trustee, Mr. De'Jon Morris, requested that a specific attendee, Emily Pecot, be removed due to her disruptive behavior. Mr. Snelling advised us that prior to our arrival Pecot was very hostile and verbally aggressive, and that they removed the Superintendent from the board meeting due to concerns for their safety. We then approached Pecot along with Mr. Snelling and in our presence both he and Mr. Morris again asked her to leave the building; which she again refused. At this point we addressed her ourselves and requested she leave the building, to which she replied " WHY? I've done nothing wrong, I'm just sitting here.". We asked her again, and again she refused to leave so we placed her in handcuffs to escort her out and issue her a short form arrest summons for Defiant Trespassing. While escorting her out Pecots colleagues began to surround and film us questioning our actions. Pecots colleagues then followed us to the car and surrounding both us and the vehicle causing a disturbance, so to de-escalate the situation we decided to transport Pecot to Central Booking at 365 Summit Ave to issue her the trespassing summons. Pecot was issued summons #0906-SF-469433 and promptly released. We then escorted her out of the building and provided her with directions back to Bergen Ave so that she could reunite with her colleagues. Lieutenant Zachowski was notified.
